(i) A recognized medical qualification included in the I or II Schedule or Part II of the third Schedule (Other than licentiate qualifications) to the Indian Medical Council Act of 1956. Holders of educational qualifications included in part II of the Third schedule should also fulfill the conditions stipulated in subsection (3) of section (13) of Indian Medical Council Act 1956. (ii) Post-graduate degree/Diploma in the concerned specialty mentioned in Schedule-VI or equivalent. **Experience:** 10 years' experience in a hospital administration in hospitals after obtaining P.G. degree in hospitals with 300 beds. **Desirable:** PG degree holder in Psychiatry.
